Terms and Conditions

- 2. The Organiser, North Notts Business Connections (NNBC), will issue an invoice upon receipt of your confirmation to purchase a sponsorship package, and which is immediately payable in full.
- 3. Once purchased, sponsorship packages are non-refundable, in part or full, and are not transferrable to any other firm. The sponsor may not cancel the contract.
- 4. The Organiser reserves the right to transfer your sponsorship package to represent another award in the event that the award sponsorship category is withdrawn for any reason.
- 5. The sponsorship package, including all promotions, privileges and tickets will be immediately withdrawn from the sponsoring firm and no refund will be due under the following circumstances:-.
 - i) If the Sponsor ceases to carry on trading, becomes insolvent (technically or formally publically declared) or, enters into or takes or is subject to any form of winding up, administration, receivership, liquidation, bankruptcy, arrangement with creditors generally or any other insolvency procedure in respect of it or any of its assets, or suffers from enforcement of security or legal process or repossession or any event analogous to any of the above in any jurisdiction then the sponsorship package will be withdrawn from the sponsoring firm and no refund will be due;
 - ii) The Sponsor is convicted of any criminal offence or otherwise so conducts itself as to bring itself, the North Notts Business Women Awards or the Organiser, North Notts Business Connections, into disrepute;
 - iii) The Sponsor is in breach of any provision of this Agreement;
 - iv) The Sponsor is in breach of any applicable local legislation, rules or regulations; or
 - v) The Organiser for any reason not otherwise provided for in this Agreement determines that it no longer wishes to hold the Event.
 - vi) If this Agreement is terminated under any of the above clauses then (a) all of the Fees paid by that time shall be retained by the Organiser, and (b) the Organiser shall have the right to claim for the balance of the Fees and for any loss or damage suffered or additional expenses incurred by or on behalf of the Organiser as a consequence of such termination.
- **6.** Postponement and Cancellation by the Organiser
 - The Organiser shall be relieved of its obligations and duties under this Agreement if any of them including the holding of the North Notts Business Women Awards Ceremony (the Event) by the Organiser, the performance of the Organiser of its obligations or attendance at the Event by Sponsors and/or visitors is impossible, illegal or substantially or materially interfered with due to any cause or causes beyond the control of the Organiser or the providers of the Venue including, without limitation, any of the following: act of God, governmental act, war, fire, flood, explosion, civil commotion, armed hostilities, act of terrorism, revolution, blockade, embargo, strike, lock-out, sit-in, industrial or trade dispute, adverse weather, disease, risk to public health, accident to or breakdown of plant or machinery, shortage of any material, labour, transport, electricity or other supply, regulatory intervention, general advisory or recommendation or any government (including any government agency or department), regulatory authority or international agency against travel, exhibition and/or public gatherings, or the Venue becomes unavailable and/or unfit for occupancy and/or use ("force majeure").
